### Introduction and special features

The MA Religion at York St John University is a vibrant, contemporary programme which focuses on the intersection between Religion and public life. You will examine the relationship between Religion and the key issues that affect all our lives including issues of poverty and inequality; diversity and inclusion; and sustainability and tackling the environmental crisis. Throughout the programme, we address the need for change towards social justice, examining the ways in which Religion has been both an obstacle to, and a source of inspiration for, bringing about positive social change.

The MA Religion is for students who want to explore the contemporary relevance of religious and spiritual beliefs and practices. In the taught modules you will be introduced to a wide variety of ideas and practices from different religious traditions and spiritualities. You will also examine different outlooks and lenses through which to make sense of the world, some of which will challenge our current understanding. Through academic rigour, criticality and empathy, we will reflect on these outlooks, working towards an approach which is inclusive and moves away from prejudice and marginalisation. We will question narrow, parochial outlooks, aiming to decolonise the curriculum.

With a key focus on research, MA Religion will introduce and develop research skills, exploring methodologies, disciplines and theoretical outlooks relevant to the study of Religion. Flexibility is built into our programme, so that you can study to suit your own research interests and preferred methodologies. These can include philosophical, theological or social scientific approaches to the study of religion and spirituality.

You will be taught by research-active scholars in the field. In addition to taught sessions, you will receive advice and tailored support through one-to-one sessions with the module leaders, your Academic Tutor and Dissertation Supervisor. Academic staff are available to help you explore your own interests and to assist you to achieve your goals.

Assessment tasks are designed to develop key transferable skills relevant to future employment. There is a 'real-world' emphasis for the programme and you will have the opportunity to engage with stakeholders, for example, religious leaders, worshippers participating in action for social justice and organisations working for social change. The MA programme draws on the vibrant research culture of the study of Religion at York St John, including [the Centre for Religion in Society](#) and the flagship [Ebor Lectures](#). You will have the opportunity to meet with, and work alongside, scholars, practitioners and opinion-formers in the field.

## **Admissions criteria**

You must meet the minimum entry requirements which are published on the programme specific webpage. In addition, you must have:

## **Programme aim(s)**

1. To explore and critically analyse the roles of Religion in public life, paying particular attention to the key issues which shape society including: diversity and inclusion, poverty and inequality and living sustainably.
2. To examine the ways in which religious and spiritual beliefs and practices can contribute to bringing about change towards social justice.
3. To equip students with the knowledge, skills and experience necessary to effectively research the roles of Religion in public life, including key transferable skills relevant to future employment, such as critical thinking and the development of advanced communication skills.

## **Programme learning outcomes**

Upon successful completion of the programme students will be able to:

- 7.1** Demonstrate advanced skills in researching particular aspects of the roles of Religion in society through independent enquiry, self-direction and knowledge of appropriate research methods.
- 7.2** Critically engage with scholarship and the experiences of practitioners and key stakeholders in the field, to produce a sophisticated analysis.
- 7.3** Synthesise and apply systematic knowledge and critical understanding of how various aspects of religion are understood in different contexts and discourses, including advanced understanding of methodological and hermeneutical issues related to the discipline.

- 7.4** Communicate the results of study clearly and precisely in ways appropriate to the discipline, showing awareness and critical understanding of the complexities of issues and the ability to reflect critically on their own particular standpoint and the perspectives that they employ.
- 7.5** Devise and produce a sustained piece of writing within the discipline, using critical evaluation of existing literature to suggest clear research questions and how these can be answered using appropriate methods, including awareness of ethical issues raised by the research.

## Learning, teaching and assessment

Teaching sessions will be highly interactive with a strong emphasis on discussion. You will be encouraged to explore your own areas of interest within the field. There will be a focus on paying attention to research methodology throughout the programme and the MA programme will equip you with the knowledge and skills necessary to carry out research, and communicate your findings, in an effective manner. Tailored feedback and one-to-one tutorials will support you in this task.

There is a wide variety of forms of assessment which have been designed to develop transferable skills relevant to future employment. These include production of web-page content, a critical analysis of a lecture, a professional report and an annotated bibliography. Your studies culminate in the production of a dissertation based on a research proposal, which takes the form of a critical analysis of an area of your own interest within the field. You will be supported by a dissertation supervisor, who can offer one to one advice to help you explore your chosen area of interest and assist you in developing your skills of independent research, equipping you to go forward and produce innovative research.
